Eligibility: Academic Senate members (members of the following series: Professor, Professor of Teaching, Professor in Residence, and Professor of Clinical X, as well as Acting Professors, and Acting Associate Professors) at the time of nomination.

Requirements: We ask that nominators adhere to all of the

requirements below, including letter writers following the specified length guidelines. Failure to do so may be grounds for the rejection of the application.

Please provide names and email addresses of **one to three** individuals (e.g., colleagues, teaching assistants, current or former students) who will provide letters of recommendation.

Letter writers will receive separate links to upload and submit their letters of recommendation. Each recommendation must follow the provided structured question template for the [selected award category](#).

Please note it is the responsibility of the nominee and/or nominator to ensure that the letter writers submit their

letters by the submission deadline. Late or incomplete applications will not be accepted.
